On July 3, 2012 the Interest Arbitration Award was posted on the NRLCA website where you can check out all the details of the award at nrlca.org under "What's New". We were very fortunate to have our National Officer, David Heather, in attendance at Ohio's State Convention and he was able to give us an explanation of the new contract. Joey Johnson, Director of Labor Relations, was seated as one of the three arbitrators and was a benefit to us in that he knows our jobs and how to carry mail. This

The package is very similar to the APWU contract with a general wage increase of 3.5%, retained the COLA with the first roll-in deferred until 2013, and there is an increase in our portion of the premium for health care at the rate of 1% per year through 2016. More specifically for our craft, a new wage schedule for new regular carriers that are hired after November 20, 2010 and a new hourly rate for RCAs hired after August 11, 2012 were established. The base rate for EMA will increase by ½ cent in 2013 and again in 2014. Mail counts will be held in February-March of each year 2013-2016. There were changes to some of the time standards that were not in our favor; but one of the most exciting features is that all of our time standards are to be reviewed and revised by an industrial engineering study that will be completed and implemented by May 20, 2015. This will be the established manner of setting time standards in the future. Again, I encourage you to study the award for yourself and if you are heading to Buffalo,





## 2011-2012 President Year End Report

It is my pleasure to submit to you my year end officers' report. It began with the post convention board meeting in Mansfield, Ohio in July 2011, where I presented my desire to expand the steward system and affect changes that would have a positive impact on grievance handling and help save this association money. This was something

I felt strongly about since my first involvement in this union and the steward system, as a local steward. Through a series of meetings and discussions with all the principle players it became clear to me, and others, that some changes needed to be made if we were going to have any chance at accomplishing this goal. The first step to implementing any significant change is to incorporate people that believe in the mission. I think that as you read through the reports submitted here you will see that this plan for our steward system has been very successful. During this time of realignment in the state, the national office put in place a change in the NRO assignments and the State of Ohio was added to David Heather's assignment list. I believe that we have communicated well and I have appreciated our ability to be candid with each other and I hope that this will be the case for future officers of this state.

Still being a fairly new board, it was proposed by Secretary-Treasurer Koren that we all chip in and rent a house in the Savannah area for the week of the National Convention. This was a novel idea and I believe that it worked out well. We were able to get to know each other a little better and it also gave us an opportunity to discuss, in a little more relaxed atmosphere, the goals and concerns for our state association. Following the national convention, came the planning and focus on this years state convention and the one scheduled for 2013 in Westlake, Ohio. District meetings were attended, a national mail count had to be endured, (you haven't lived until you've been in the plants until 4:00am, then showered and went to work on your route). Thankfully, with the changes in the steward system, they were able to handle the grievances quickly and efficiently throughout the state. I would like to take this opportunity to commend the assistants, area and local stewards of this state. Under the direction of State Steward Hutchisson, they were able to handle all of the new grievances and many, if not all, that were backlogged.

With the spring comes new planning for the State Booster meeting and District meetings. I believe that the booster meeting was a great success. VP Edler and the Committee people involved did a great job. We have tried to bring new ideas to our meetings; new concepts, new fun filled events for you the membership. I hope that if you have enjoyed the meetings that you have attended that you will spread the news amongst your fellow carriers; that have not been to a state meeting in awhile.

Of course, with all the events enveloping the Post Office, there have been a lot of meetings with Congressional Representatives and Senators, including a town hall meeting with Rep. Bill Johnson in Salem, Ohio. I also gave interviews to the NPR radio network and the Jeff Santos radio show out of Boston. The legislative seminar in May put VP Edler and myself in the Congressional offices on Capitol hill. It's a daunting task to try and convince some of these members of Congress that the Postal Service is not part of a national dept crisis and should be left alone to function as it always had, before impossible congressional mandates. The battle continues and with the involvement of carriers like you throughout the state, as well as the nation; I'm hoping that we can push back even further any of the crippling ideas that have been proposed lately.

As for my recommendations: I believe that we must continue to follow a budget. That we need to watch our finances and save on expenditures. That we need to keep from making wholesale changes in structure and finances until we see what the ramifications of a National Steward System brings about. We must not be complacent about our role in making sure that our state association remains strong and insists on the protections promised to our members. And most importantly, we must reinforce a philosophy that focuses on what is best for the rural craft as a whole, rather than individual agendas. No one person should consider themselves more important than the best interests of the Association.

In closing, I would like to say that the long hours, the personal sacrifices, the sleepless nights and the occasional criticism, are a lot more tolerable when I think about the good people of this association!

It was an honor to serve you as President this past year. I enjoyed working with State Steward Hutchisson. and the assistants. The State Board, along with your stewards, have gone the extra mile to bring our goals within our grasp. It goes without saying that people with honesty and integrity are the cornerstone to a successful organization.



## **State Steward Year End Report**

Distinguished guests, fellow officers, delegates, and all members of the OHRLCA assembled here in Dayton for our 110th Annual State Convention. It is indeed an honor and a privilege for me to present my Annual Report as your last State Steward.

Following the 2011 State Convention I served as a National Paid delegate at the National Convention in Savahanna, GA. I was proud to be part of this de-

mocratic process as I helped elect six officers to the National Board. The convention was historic for two reasons. First was the passing of the National Steward System and second the delegates elected the associations first female President.

I am currently serving as your last State Steward and I have accepted the position of Northern Ohio District Representative. Catherine Funderburgh has accepted the position of Cincinnati District Representative. Together with the help of Assistant District Representatives, Michael Aitchison, Michael Wallis and Susan Thayer we will continue to serve the rural carriers of the State of Ohio and a small portion of Indiana and Kentucky. The NRLCA Steward System will change from a state based steward system to a district based steward system on November 3, 2012.

The steward system in Ohio is now ideally positioned to have a seamless transition into the National steward system. In my first year as your State Steward I completely reorganized the steward system to be more cost efficient. We continue to see revenue go down with our costs trending upward. Cutting services was not an option and when I asked the board to bring on more assistants I had some explaining to do. Through careful research the Board has given me all the tools I needed to be successful. First I divided the state into 5 geographical regions and assigned an assistant to each region. This reduced our travel expense over the same period last year by \$13,000.00 dollars. Second, strict measures were implemented to ensure that stewards scheduled two and three meetings on days that they were in a travel status. This reduced our ADOP expense by \$14,000.00 dollars. Third, by changing operating procedures on the use of certified and express mail I was able to reduce our mailing expense by \$5,500.00 dollars. Overall I was able to reduce the steward system operating budget at a cost savings of approximately \$33,000.00 dollars.

Grievance activity has remained strong over the past year. We have processed approximately 415 grievances with 115 being discipline issues and 280 being contractual with 20 being class actions. The disciplinary grievances range from express mail scan failure, misdeliveries, failure to follow instructions, motor vehicle accident, abuse of leave, and theft. Removals in the state have risen with seven and fourteen day suspensions on the rise also. The National Mail Count that was ordered in September helped reduce our overall mail count grievances as we did not have many issues and on average across the state routes went down by 24 minutes. A February/March mail count would have resulted in more route losses and transcended into greater grievance activity.

I have been busy attending pre-disciplinary interviews with management. This is important because we can sometimes prevent further action by management at these meetings. The stewards have worked very hard to settle most issues at the lowest step of the grievance arbitration process. In most cases a grievance will be settled with the grievant being notified as to the resolution

within 30 days of filing. The step 2 process was streamlined and we usually have less than 10 files to be adjudicated at that level on any given day. Ohio is the sixth largest state in number of rural routes and since I became state steward we have only appealed one grievance to step three compared to almost 1800 for the rest of the country. We have been very successful in getting favorable settlements for our carriers at the state level.

Following the National Convention I returned to Ohio with a very busy fall schedule. I attended eight district meetings, Four as State Steward and the rest as a guest of the association. I spend long hours educating myself on Postal issues that matter to rural carriers and appreciate the opportunity to share this information at your district meetings. Your feedback is valuable to us and I have discussed all of your concerns with President Tom Gamble and our National Committeeman David Heather. No one person can run the OHRLCA and I could not do this job without the support of my fellow stewards and the State Board. It is truly a team effort in managing this association and we work hard to resolve all of your issues.

A National Mail Count was called in September and we had to scramble to hold training classes for the carriers across the state. The data showed us that the free fall in mail volume was over. Mail volume was flat in some areas and off the charts in others, but over all we seen a slight decrease that resulted in lower evaluations. I received a large volume of phone calls from carriers at this time. I set up a daily phone schedule meeting with the three rural analysts to discuss issues as they arose during the mail count as a preemptive measure to resolve issues before they became grievances. This preplanning resulted in a lower than normal volume of mail count grievances. I and my team of stewards as well as President Gamble physically inspected all the plants and distribution centers at the beginning and end of the mail count. The FSS facility at the Cleveland annex did experience mail flow problems that will be addressed through a class action grievance filed by National Committeemen David Heather directly at the step three level. The team found no other major discrepancies to report. We were able to keep the pressure on management to get the mail out of the plant and into the AO's during the count.

In January I attended the South Atlantic regional conference (SAC) in Atlanta Georgia. The National Collective Bargaining Agreement and the ongoing arbitration was the main topic of conversation. President Dwyer assured everyone that the National Board was doing everything possible to achieve a favorable outcome. I also attended the Eastern States Conference in Erie, PA as it was on my way home from National Steward Seminar that Sr. Asst' State Steward Michael Aitchison and I attended. The training is mandatory and Mike and I learned a lot from being in attendance.

The Mid-States Conference was held in Topeka, KS this past May. Ohio was well represented at the conference with carriers and Board members. There was a lot of discussion about a five day work week and doing away with Saturday delivery. At present support is waning on Capitol Hill for this change and it would take an act of congress to eliminate Saturday delivery. I found the conference to be very informative and I was not disappointed in the level of discussions and topics affecting the rural craft as we go forward in 2012

The spring district meetings are always well attended and I was assigned to four as the State Steward representative and I attended four as a guest of the association. I was able to pass on

valuable information involving contract issues and how to avoid possible discipline issues that were going on in each district. We discussed FSS and routes being released that were previously held open as impact buffers. I helped districts draft resolutions and elect delegates to this convention. We accepted new applicants as members into the NRLCA. I would like to welcome you all and hope you are here today.

I have conducted with the help of Penny Koren and Floyd Edler many local steward certification classes. The National Constitution mandates that all stewards complete enhancement training. I have scheduled and trained 75 local stewards to date. The classes are on Sundays and the district meetings are on Saturdays so I have been working almost non-stop for three months.

To date the grievance work load in the Northern Ohio District is the same as last year without a National Mail Count. I am very concerned with the increased level of grievance activity. Removals in the NOD have risen with other discipline trending up

as well. Contractual grievances are still the majority and this year the National Reassessment Process added greatly to that work load. NRP grievances and interactive meetings consumed a lot of my time.

The disciplinary grievances range from express mail scan failure, misdelivery, failure to follow instructions, motor vehicle accidents, abuse of leave, and theft.

In conclusion I would like to thank you for allowing me to serve this association as your State Steward. Thank you to all the Stewards that have helped me at meetings and the Auxiliary Board for all their contributions. Finally I would like to thank the Ohio Board for their professionalism and dedication to the betterment of the rural craft.

## September Mail Count, I Know It's Crazy, But Here Are The Training Dates So Come See Us MAYBE

In the event that the USPS calls for a national mail count pursuant to Article 9.2.C.3.a.4 of the National Agreement, I have scheduled mail count training classes around the state. The Employer reserves the right to conduct a national count of mail for all rural routes during the last twelve (12) working days in September of any year. The employer agrees to notify the Union at the national level at least thirty (30) days in advance of the commencement of the count. If headquarters calls for a mail count under this subsection it will start on September 17, 2012 and end on September 29, 2012. Mail count training dates and locations are subject to change so please check the www.ohrlca.org website for the most current up to date information as more classes may be added. Mail count meetings are conducted for the benefit of union members only and space is limited.

#### Membership

The 2011-2012-membership year began with 4,421 members and ended with 4,204, a decline of 217 members. Ohio has been on a steady downward trend because the Postal Service stopped hiring RCAs in 2009.

Ohio has 475 non-members which is 74 less than 2011 total of 549 non-members. Thank you to the Stewards, Academy Trainers, Board and District Officers and Members who assisted in recruitment efforts.

#### **Financial**

A complete Financial Report was presented in the convention report showing income greater than expenses by over \$37,000. The income has many contributing factors. The most important of which is the cooperation of everyone to reduce expenses and to stay within budget. Other contributing factors are: a full year of the dues increase passed in 2010, a change up in the stewarding, added additional Assistant State Stewards (which reduced steward expenses). Also having a full-time employee, who retired, reduced the cost of employee benefits.

The Budget Committee projected accurately the end of the year income, however the projected income was reduced by \$13,000 because of unexpected expenses. These unexpected expenses were 9 appeals filed with the State Association and appealing decisions made by the Executive Board. These appeals required your Executive Board to meet and investigate the matters resulting in increased expenses due to travel, lodging and wages.

#### **Activity Report**

I have been very busy this past year. I have attended a training class in Savannah GA on August 15th, one day prior to the National Convention. October 3 – 7, 2011, I attended a Secretary-Treasurers Training in Alexandria VA. May 5-7, I attended the Mid-States Conference in Topeka KS, which included a Secretary-Treasurer training.

Along with the trainings, seminars and conferences I also completed the following: a guest speaker at two Fall and two Spring District Meetings, designed and printed district meeting postcards, trained 15 Secretary-Treasurers, assisted in a Newly Elected Local Steward Training, presented a Financial report during the Spring Booster, sent membership recruitment letters, main-

## NPMHU Brief Challenging USPS Network Rationalization Changes Before PRC

As previously announced, in December 2011, the Postal Service filed a request with the Postal Regulatory Commission (PRC) seeking an Advisory Opinion regarding the Postal Service's plan to consolidate its processing network and substantially lengthen service standards, including the elimination of overnight delivery for

first-class mail. Under the Postal Reorganization Act, the Postal Service must seek such an Advisory Opinion from the PRC before it implements any "change in the nature of postal services which will generally affect service on a nationwide or substantially nationwide basis."

The NPMHU immediately intervened in the PRC proceedings and, over the course of the last several months, has been submitting written interrogatories and other document requests, attempting to uncover whether the Postal Service has overstated the anticipated savings and under-estimated the difficulties of the closings and consolidations currently planned. Counsel for the NPMHU had the opportunity to cross -examine postal witnesses at live hearings spanning from March through June. The NPMHU also submitted affirmative written evidence to explain how the proposed changes would adversely affect mail service and mail handlers and other postal employees.

The NPMHU has now filed its first post-hearing brief on this matter. Here a few excerpts from that submission:

The Commission is charged by Congress with giving its considered opinion on this Postal Service proposal, as the planned service standard changes will "generally affect service"—indeed, substantially degrade service—"on a nationwide . . . basis. In so doing, the Commission is required by statute to consider whether the Postal Service's plan shows due deference to the policies contained in Title 39, including the following specific service standard objectives stated in 39 U.S.C. § 3691:

- (A) To enhance the value of postal services to both senders and recipients.
- (B) To preserve regular and effective access to postal services in all communities, including those in rural areas or where post offices are not self-sustaining.
- C) To reasonably assure Postal Service customers delivery reliability, speed and frequency consistent with reasonable rates and best business practices.

The ultimate question before the Commission is whether the Postal Service's proposal is reasonably calculated to achieve these objectives, and, more pointedly, whether its proposal is a necessary and appropriate measure to preserve "reasonable rates." Based on the record of evidence before the Commission, the NPMHU submits that the Postal Service has not done the proper analysis to support the conclusion that its proposal is indeed such a necessary and appropriate measure.

The NPMHU urges the Commission to issue an opinion finding that the Postal Service's proposal is ill-advised. The Commission should advise the Postal Service to undertake additional analysis before dismantling a time-tested network that would be prohibitively difficult and expensive to re-create. In particular, the Postal Service should be advised to recalculate its anticipated savings to correct indefensible estimates and miscalculations; to submit its proposed network to a simulation model to ensure that the network can operate as planned; to test, through a pilot project, whether the proposed expanded operating windows are feasible and what the associated maintenance effects will be; to develop a more defensible method of determining what, if any, productivity improvements can be achieved through expanding the operating window; to consider how its proposed network could facilitate or foreclose entry into burgeoning markets; and to investigate what savings could be achieved while maintaining overnight delivery for some substantial portion of First -Class Mail.

While it is beyond dispute that the Postal Service must take timely steps to address realistic financial constraints and a changing postal market, it is the province of the Commission to ensure that these steps will result in the improvements in savings and efficiency predicted by the Postal Service, rather than to further degrade an important public service. Seven months of proceedings before the Commission have shown that the Postal Service is poised to dismantle one of its most important assets— its extensive national network for processing and distribution of mail—without having done the homework for either the Postal Service or the Commission to determine that its plan is feasible, or advisable. As such, the Commission should render its opinion finding this proposal ill-advised.

Reply briefs are due later this month, and the PRC is expected to issue its opinion in late summer or early fall.


#### Carla B. Dedden – Executive Committeeman

It has been a very exciting year for me. My desire to help and do something for this union became a reality. I knew when Sandy Laramee announced she was retiring as editor and the State Board was taking applications that this was my opportunity. I previously worked at the Farm and Dairy / Lyle Printing for 13 years. Therefore I have experience and knowledge of the printing and publishing industry. I sent in my resume and was appointed Editor of our state paper in August of last year. I started out following Sandy's format but have added my own style since. I really enjoy and love this position. I am trying to make the paper more appealing to read so I am open to any suggestions or comments you may have.

## **Constitution Changes**

#### Article V.2.D Previous Language:

The Executive Committee shall consist of the four elected State Committeepersons. Its duties shall be of an advisory and supervisory nature and to take charge of any office vacated for any cause, not otherwise provided for, and see that such offices are properly filled by some suitable person; to act as mileage and per diem committee; to act as a Road and Legislative Committee, whose duties shall be to look after all matters pertaining to the betterment of mail route roads and such other matters as require action in the Ohio Legislature, when directed to do so by the Executive Board or the Convention.

#### **Adopted Language:**

The Executive Committee shall consist of the four elected State Committeepersons. They shall act as Trustees of the Association. Its duties shall be of an advisory and supervisory nature and to take charge of any office vacated for any cause, not otherwise provided for, and see that such offices are properly filled by some suitable person; to act as mileage and per diem committee and other matters requiring action as directed to do so by the Executive Board or the Convention.

#### Article V.4.D

#### **Previous Language:**

An active regular rural carrier who is serving as the Secretary-Treasurer on a full-time basis shall receive an annual salary of a 46 hour evaluated route at the carrier's attained step. The salary shall be payable on a biweekly basis. Benefits and allowances shall be payable in the same manner as that for a State Steward as described in Article X Section 5 A paragraph 1,2,3,4 of the Constitution.

#### **Adopted Language:**

An active regular rural carrier who is serving as the Secretary-Treasurer on a full-time basis shall receive an annual salary of a 46 hour evaluated route at the carrier's attained step. The salary shall be payable on a biweekly basis. Annual Leave: Be granted annual leave days equal to attained annual leave level with the Postal Service per Association fiscal year. All annual leave requires the approval of the State President. Any unused annual leave shall be payable at the current cash equivalent at the end of each fiscal year (June 30).

Sick Leave: 13 days per Association fiscal year. Sick leave days will be carried over from year to year. Any unused sick leave at end of the employee's tenure as Secretary-Treasurer will be handled in accordance with the method used by the retirement system in which the employee is enrolled. The State Board shall set aside annually an amount equal to the value of any unused sick leave at the end of the fiscal year.

Payment of Postal Service's share of benefit costs: The State Association shall assume and pay those costs of benefits normally paid by the Postal Service for such employee such as retirement, health insurance, life insurance, etc.

#### Article VIII. Section 3 Meetings No Previous Language

#### New Adopted Language

C. All State Board Meetings are open meetings to any member of the Association who wishes to attend. The State Board may vote to go into Executive Session for a specific reason.

#### Article X

#### **Previous Language:**

Steward System

Section 1. Responsibility. Representation, provided for in the National Agreement, shall be accomplished through the Steward System. The NRLCA shall be responsible for the Steward System throughout the Nation. The NRLCA Stewards shall be responsible for processing grievances and appeals through the Grievance-Arbitration procedure. The Association, as the exclusive bargaining agent, is the only organization authorized to represent Rural Carriers in matters of labor-management relations.

Section 2. Role of State Associations

A. State associations, under the direction of the assigned National Executive Committeeman, shall be responsible for the implementation and operation of the Steward System within their state.

B. State associations shall recommend to the National Association the name of a member to serve as State Steward, and in conjunction with the State Steward, shall recommend to the National Association the name(s) of a member(s) to serve as the Senior Assistant State Steward(s), Assistant State Steward(s) and as the Area Steward(s).

Section 3. Selection.

A. Appointment of Full-time State Steward. The Executive Board shall appoint a full-time State Steward who will serve under the direction of the President. Such person's duties shall be to supervise the operation of the Steward Program in the State. The appointee cannot be or become an executive board member while serving as full time State Steward

B. Senior Assistant Steward. Appointment of Full-time Senior Assistant State Steward. The Executive Board, in consultation with the State Steward may appoint full-time Senior Assistant State Steward(s), as deemed necessary by the Executive Board, who will serve under the direction of the State Steward. Such persons' duties may be to assist in the operation of the Steward Program in the State. The appointee(s) cannot be or become an executive board member while serving as full time Senior Assistant State Steward.

(See footnote for bold underlined wording.)

C. Assistant State Steward. The Executive Board may appoint one or more Assistant State Steward(s), who will serve under the direction of the State Steward, to assist in the operation of the Steward Program;

A. Salary of State Steward. The State Steward shall receive a basic salary equal to the annual salary of a rural carrier in Step 12 on an evaluated 48 hr route. plus an additional salary of \$9,600 per annum to compensate for the qualifications of the steward necessary to perform the duties The salary shall be payable on a biweekly basis.

B. Salary of Senior Assistant State Steward(s). The Senior Assistant State Steward shall receive an annual salary of a 46 hour evaluated route at the carrier's attained step plus an additional \$75.00 per pay period. The salary shall be payable on a biweekly basis. Section 5. Benefits and Allowances.

#### A. State Steward

- 1. Annual Leave: 26 days per Association fiscal year. All annual leave requires the approval of the State President. Any unused annual leave shall be payable at the current cash equivalent at the end of each fiscal year (June 30).
- 2. Sick Leave: 13 days per Association fiscal year. Sick leave days will be carried over from year to year. Any unused sick leave at end of the employee's tenure as State Steward will be handled in accordance with the method used by the retirement system in which the employee is enrolled. The State Board shall set aside annually an amount equal to the value of any unused sick leave at the end of the fiscal year.
- 3. Payment of Postal Service's share of benefit costs: The State Association shall assume and pay those costs of benefits normally paid by the Postal Service for such employee such as retirement, health insurance, life insurance, etc
- 4. Payment of expenses: Actual transportation expenses at the rate received by State Board members and \$25.00 per diem while away from home on Association business shall be payable. Also \$23.00 per pay period shall be paid toward maintaining an office.
- B. Senior Assistant State Steward
- 1. Annual Leave: Equal to attained annual leave level with the Postal Service per Association fiscal year. All annual leave requires the approval of the State Steward. Any unused annual leave shall be payable at the current cash equivalent at the end of each fiscal year (June 30)
- 2. Sick Leave: 13 days per Association fiscal year. Sick leave days will be carried over from year to year. Any unused sick leave at the end of the employee's tenure as Senior Assistant State Steward will be handled in accordance with the method used by the retirement system in which the employee is enrolled. The State Board shall set aside annually an amount equal to the value of any unused sick leave at the end of the fiscal year.
- 3. Payment of Postal Service's share of benefit costs: The State Association shall assume and pay those costs of benefits normally paid by the Postal Service for such employee such as retirement, health insurance, life insurance, etc
- 4. Payment of expenses: Actual transportation expenses at the rate received by State Board members and \$25.00 per diem while away from home on Association business shall be payable. Also \$23.00 per pay period shall be paid toward maintaining an office.
- C. Assistant State Stewards shall receive a salary of up to \$75.00 per pay period, an office allowance of up to \$23.00 per pay period, and be paid while on Association business, ADOP, actual expenses and \$25.00 per diem.
- D. An Area Steward shall be paid \$25 per month salary and \$49.83 per month office allowance, and while on Association business, ADOP, actual transportation expenses, and \$25.00 per diem, with the approval of the State Steward.
- E. No sub-hire will be paid to any steward to attend statewide meetings unless the Constitution directs differently. The Executive Board may determine if an amount equivalent to that of the regularly elected delegates will be paid to the State Steward or Assistant State Steward to attend the National in the event either is not elected as a delegate.

Section 6. Duties and Responsibilities of Stewards.

- A. Regulations governing State Steward Position
- 1. The State Board shall be responsible for over—seeing the work-hours of the State Steward. To make this possible, the State Steward shall be required to file a periodic report of all hours worked, as directed by the State Board.
- 2. The State Steward shall be expected to be on duty involving the tasks of the position as required but no less than 48 hours per week. Time spent on duty may be broken up and flexible to accommodate the needs of the position and the schedule of working carriers.
- 3. State Convention: The State Steward shall be considered in official duty status during the entire State Convention.
- 4. State Booster Meetings: The State Steward shall be considered to be in official duty status for the entire meeting.
- 5. National Convention and Steward's' Seminars: The State Steward shall be considered to be in official duty status only during the required Stewards' Seminar and any travel days approved by the State President
- 6. District Meetings: The State Steward shall attend at least two District meetings each year. Attendance at such meetings shall be considered on duty.
- 7. National Committee or Task Force Assignments: The State Steward shall be required to use annual leave or leave without pay (LWOP), at the steward's option, for any days spent in such National assignments. Saturday and Sunday would not be considered as work days missed and would not necessitate the use of annual leave or LWOP.
- 8. The State Steward shall be responsible for the direction of the Senior Assistant State Steward.
- B. Senior Assistant Steward
- 1. The State Steward shall be responsible for over-seeing the work-hours of the Senior Assistant State Steward. To make this possible, the Senior Assistant State Steward shall be required to file a periodic report of all hours worked, as directed by the State Steward.
- 2. The Senior Assistant State Steward shall be expected to be on duty involving the tasks of the position as required but no less than the evaluated hours per week equal to the route normally assigned. Time spent on duty may be broken up and flexible to accommodate the needs of the position and the schedule of working carriers.
- 3. State Convention: The Senior Assistant State Steward shall be considered in official duty status during the entire State Convention.
- 4. State Booster Meetings: The Senior Assistant State Steward shall be considered to be in official duty status for the entire meeting.
- 5. National Convention and Steward's' Seminars: The Senior Assistant State Steward shall be considered to be in official duty status only during the required Stewards' Seminar and any travel days approved by the State Steward
- 6. District Meetings: The Senior Assistant State Steward shall attend at least two District meetings each year. Attendance at such meetings shall be considered on duty.
- 7. National Committee or Task Force Assignments: The Senior Assistant State Steward shall be required to use annual leave or leave without pay (LWOP), at the steward's option, for any days spent in such National assignments. Saturday and Sunday would not be considered as work days missed and would not necessitate the use of annual leave or LWOP.
- C. Assistant State Stewards
- 1. The Assistant State Steward shall be responsible to the State Steward and to the State and National Association for the performance of all duties.
- 2. Duties
- A. Represent carriers in offices assigned by the State Steward;

- B. Serve with the same authority as the State Steward, under his/her direction;
- C. Appeal grievances to Step 2 and Step 3 in the absence of the State Steward and in conjunction with the Executive Committeeman.
- D. Area Stewards
- 1. Area Stewards shall be responsible to the State Steward. Area Stewards shall be certified in no more than 20 offices in a specific geographic area, as determined by the State Steward. Area Stewards are equal in authority to a Local Steward and have no authority in an office that currently has a Local Steward.
- 2. Duties
- A. Represent carriers in offices assigned by the State Steward;
- B. Process grievances through Step 1;
- C. Appeal grievances to Step 2 and forward the original file to the State Steward.
- E. Local Stewards.
- 1. Local Stewards shall be responsible to the State Steward and have no authority until certified.
- 2. Selection

A Any member in a local office or a delivery unit may be elected Local Steward and shall serve until a successor is elected and certified or until he/she resigns. Where a local steward is in place, any member may call for an election in the month of July of every fourth year. An election may also be called for any time the position is vacant, or when a majority of the members submit a petition to the State Steward for approval.

A. Local steward elections require written notifications to all members at least 15 days before the date of the election. Election shall require a majority of votes cast by members in a local office or a delivery unit. In the event of a tie vote, the state association, upon recommendation of the State Steward, shall select a steward to serve in that office or delivery unit until a new Local Steward has been elected and certified.

B. When more than one Local Steward has been elected in a delivery unit, a Chief Steward shall be elected by the members of that delivery unit. When an office is comprised of multiple delivery units, a Chief Steward shall be elected from among the current local stewards by all members of that office and shall represent the craft in matters that concern the entire office. A Chief Steward shall be selected by the State Steward in the event of a tie. The Chief Steward of the office shall also serve as the Local Steward for delivery units where no Local Steward has been elected.

- 3. Duties
- A. Assist any rural craft employee who feels aggrieved and accompany the grievant during any discussion with management, if the employee desires;
- B. Meet with the Postmaster or designee as expeditiously as possible to jointly develop the facts in the grievance file and attempt to resolve the grievance when the Step 1 discussion has failed;
- C. Appeal grievances to Step 2 and submit the original file to the State Steward;
- D. Represent the rural carrier craft in the office or delivery unit;
- E. Maintain certification by attending annual enhancement training and other training as required. Failure to do so will result in decertification by the State Steward.

#### Adopted Language:

#### Article X

Upon implementation of the proposed National Steward System effective prior to the 2013 OHRLCA State Convention, refer to the NRLCA Constitution Article IX.
