JAMES REINHART



CARRIER MILESTONE

It was January, 1961 when James Reinhart was appointed to the route in Botkins, Ohio. It was not the typical appointment, as another individual had already been named as the carrier on the route. Being astute and aware of the qualifications for being assigned the route, he made a visit to his local congressman, Bill McCullough, and because of his time served in the army, he was awarded the position as rural carrier for the Botkins Post Office. Very shortly after starting on the route, he signed his name on the bottom line as a member of the National Rural Letter Carriers Association. Jim served the people who lived on that route for twenty-eight years until he retired in February, 1989. He worked six days a week for the Postal Service and seven days a week on his dairy and grain farm. He was a busy man, but always had time for his family, church and the NRLCA. He attended the county meetings where he served a term as president and also served as president of District 13. For fifty years, he has attended all of the spring district meetings with the exception of 1987 when his son was married on the same evening as the meeting. A major benefit to belonging to the association while he was an active carrier and now as a retired carrier is the health insurance.



At the 2011 fall meeting of District 13, Jim Reinhart was presented his fifty year membership award by his daughter, Janna Hirschfeld, President of District 13 and current carrier on the Botkins route. He received a 50 year pin, a certificate and a copy of Lester Miller's history of the rural craft. Jim's wife, Evelyn, of 60 years was also there for the presentation. Bipartisan Postal Reform Bill S-1789 Clears Senate Oversight Panel

Chairman and sponsor (D) Senator Joseph I. Lieberman, co-sponsors (D) Thomas Carper, (R)Senator Scott Brown, (R) Senator Susan Collins and members of the Senate Homeland Security and Governmental Affairs Committee voted 9-1 in favor of the 21st Century Postal Service Act.

This would pave the way to allow the Postal service to recoup \$ 7 billion overpayment to the Federal Employees Retirement System and to use those funds to offer buyouts to 100,000 employees. The bill would also restructure prefunded retirement health benefits, reduce the payment goal to 80 percent, and require USPS to negotiate

with its unions to develop a new employee health care plan. The bill would also provide for a 2 year delay in deciding the fate of Saturday delivery.

Although we welcome a two-year delay in the elimination of Saturday delivery, Make no mistake-the prefunding policy will guarantee continued financial losses and will ensure the end of six-day delivery in 2014. This will cost 80,000 good full-and part time postal jobs. Phasing out door-to-door delivery will cost tens of thousands of other good jobs while risking a very negative public backlash from the 35-40 million households and business that now receive door delivery.

However, the impact on our own jobs is not the only concern. These policies will severely damage the quality of service provided by USPS and therefore damage the entire \$1.3 trillion mailing industry, whose 7.5 million privatesector jobs depend on a healthy Postal Service. Mail delivered to the door is more valuable to mailers than mail delivered to remote receptacles. Slower mail service arising from the elimination of six-day service represents an effective rate increase for mailers. Together, these changes will cause serious harm to thousands of firms in our industry and threaten the long-term viability of the Postal Service. In other words, the jobs lost in the USPS could be the tip of the iceberg. At a time of mass unemployment in the United States, this hardly makes sense. Given that the Postal Service is the nation's largest employer of veterans, downsizing the Postal Service also means adding to an already alarming jobs crisis for the nation's veterans who are coming home from Afghanistan and Irag.

The legislation proposes a number of interesting ideas to help the Postal Service control its health care costs, including a mandate for postal annuitants to enroll in Medicare Parts A and B when they reach the age of 65 and the development by OPM of Medigap policies tailored for such annuitants. This proposal is worth serious consideration, as

is a provision that gives the Postal service and its unions the option to negotiate a USPS Health Benefit Plan.

Among the most positive provisions of the bill is the one that authorizes the OPM to return any surplus in the Postal Service's account in the Federal Employees Retirement System to the USPS. These recovered funds could be used to pay for early-out incentive programs (payments of up to \$ 25,000 or additional service credit for retirement eligibility and benefits), to cover the costs of workers' compensation expenses or pre-funding payments for retiree health benefits, or to pay down the Postal Service's debt. We should support this provision and urge Congress to apply the same principle to the CSRS postal surplus identified by the independent audits commissioned by the Postal Regulatory Commission and the USPS Office of the Inspector General.

The legislation would also help the Postal Service increase its revenue by legalizing the shipment of beer and wine through the mail and permit the USPS to offer non postal products.

Regrettably, S. 1789 suffers from unfair provisions, most notably the inclusion of a form of the Federal Employees' Compensation Act that will cut the compensation benefits of injured workers who reach retirement age would see their benefits cut to 50% of their salary at the time of their injuries, Plunging into poverty those with long-time disabilities as a result of their inability to save through the Thrift Savings Plan.

Also included in the bill is a provision that is designed to tilt interest arbitration process in the favor of postal management by instructing arbitration boards to consider management's top bargaining objectives (comparability and profitability) when issuing decisions-while not mentioning the factors most important to the postal employee unions. This would no doubt have the effect of biasing the dispute resolution system against the unions.

Conclusion: As drafted, the 21st Century Postal Reform Act of 2011 will not save America's Postal Service. On the contrary, it will hasten its decline and threaten the long-term viability of the USPS. This poses a danger to the entire \$1.3 trillion mailing industry.

Congress must do its part and avoid destructive policies driven by short term Congressional Budget Office 'scoring concerns'. Such concerns led to the prefunding mandate adopted in 2006 that has nearly destroyed the Postal Service.

As a union we must work with members of the Senate to truly reinvent the Postal Service for the 21st Century by improving S. 1789 in ways that will make it worthy of its name

Christmas Pay Procedures: The 2011 Christmas period for rural carriers begins Saturday, December 3rd (week 1, PP-26) and ends Friday, December 23rd (PP-01) and the Christmas Allowances and Procedures under Article9.2.K will be in force. Article 9.2.C.5.j tells you that

an X-day earned between the start of the Guarantee Year and the end of the Christmas Period must be taken during that pay period and previously earned X-days may not be taken during this time frame. Article 9.2.C.5.k The period of October 22nd thru December 23rd would not count as part of the 12 weeks in which an X-day must be received by the carrier. Article 11.2.C says that if a regular rural carrier is required to work on the designated Christmas holiday, such carrier shall receive one and one-half (1 ½) times the daily rate of pay in addition to the holiday leave pay. Article 11.2.D....regular rural carriers shall not perform auxiliary assistance on any designated holiday or actual holiday. Article 11.2.E....a leave replacement may be utilized to perform duties on a holiday and will be paid actual hours worked.

Acts of God: Severe weather language is found in Article 30.1.H of the National Agreement. The Language says that if Acts of God prevent an employee from performing the employee's duty, administrative leave may be authorized. The ELM in section 519.2 through 519.224, gives scenarios for "early dismissal". The PO 603 sections 142.11 through 142.123, give you the language for Equipment Maintenance Allowance for miles driven. If severe weather causes you to be unable to get to work, causes you to be unable to take the mail out and deliver it or causes the principle receipt of mail to your office to be impossible; you may be involved in an Act of God situation. Call the steward in charge of your office immediately. Remember: We must try and attempt delivery and an Act of God will normally affect many people in multiple crafts and in multiple offices and shifts.

National Steward Recognition Week: December 5-12 is National Steward Recognition Week and I want to take this opportunity to introduce you to your new Assistant State Stewards here in Ohio. Mike Aitchison is the Sr. Asst. State Steward, with Cathy Funderburgh, Susan Thayer, and Mike Wallis just completing their certification training as Assistant State Stewards. If you have any questions please refer to the map on page 6 for the assistant in your area before you direct your calls and remember to only call one steward.

These new assistants along with the local and area stewards have learned from many adverse situations that occurred this year and their resolve and determination is admirable. If you would just say "thank you" to them, I would greatly appreciate it. They are a special group of people who want to make our jobs safe and secure and to insure that our contract is protected and honored. There are approx. 650

(Duo Offices not included) offices in Ohio, with rural delivery. We need to have at least half of them covered by a steward in order to properly protect you and to at least know what goes on in this half of the offices. We have training in the works for the first part of the year. Can we count on your office to elect a local steward and have one of your own trained to work with me and protect you? Remember: Management is under no obligation to inform you of your rights or your benefits!

When you call a steward from your cell phone, remember the connection may not be clear. We may not even be able to hear your name or number. If you do not hear from us within 24 hours; call back. If you have internet capability, use www.NRLCA.org, go to Steward Reference, go to alphabetical, look up the subject that concerns you. You will be surprised what good information you can find there! It sure beats the gossip and opinions of some of these so-called local experts in some of our offices. Protect yourself and your family, get true and accurate information from official sources.

Non-Steward Questions: Union stewards are not allowed to discuss certain things. They are;

EEO's (reporting mistreatment because of race, creed, sex etc.) we **do not represent** the carrier in the EEO procedure.

MSPB deals with a person's rights under Veterans Laws that hold special protections for the carrier as a federal employee. We are not able to enter into those areas, under any circumstances.


OPM is the controlling entity for that wonderful thing you and I call "retirement". We do not even have the ability to see the records that are used to calculate retirement. (bad advice from one of us could harm you and mean a big loss of money)

OWCP is Worker's Compensation. The doctor that treats you is really the person in control. The process is administered by the Department of Labor. We have no ability to control the Department of Labor, and a steward can only help in a limited capacity. We do have a resource person at the national office and his name is Devin Cassidy (703-684-5545). Mike Watson & Associates can be reached at (503-653-2911) and they are very knowledgeable on worker's compensation issues.

Revised Board Policy

Corrective Action

May 14, 2011 revised to read;

Corrective action may be imposed on any OHR-LCA member elected or appointed to a position within the Association for the following reasons, but not limited to;

- A. Violation of the constitution or policies set forth by the OHRLCA State board.
- B. Neglect of duty or breach of the Constitution.
- C. Conduct detrimental to the welfare and interest of the membership or the Association
- D. Conduct which hinders the due process of the grievance procedure.
- E. Instigating or engaging in acts on the side of management that violate the principles of the National Agreement or Constitution.

Currently the membership for Ohio is 4,332 total members a decrease of 230 members since November of 2010. Printed in this issue is a breakdown of members and non-members for each district. The District's revenue is calculated on members who are regular carriers; increase your regular carrier membership, which will increase your District's revenue.

During the 2011 Ohio State Convention I announced, if I were reelected to the position of OHRLCA's Secretary-Treasurer, I would retire from the USPS. After 30 years, carrying Rural Route 6 in the Carrollton Post Office, I retired on September 30th.

My advice to anyone planning on retiring, plan ahead, request an annuity estimate and retirement packet at least 6 months in advance.

Schedule your counseling session at a time when there will be no interruptions. Copy the required forms to be completed. Fill in the copied forms and write down your questions in the order of the forms. Make corrections on the copied forms, when confident of your answers, complete the originals and return them to shared services.

Be financially prepared, your pension payments will be reduced for at least 6 months until OPM completes calculating your pension. Also the interim pensions still doesn't include the Social Security supplement some FERS retirees are owed, which is usually worth several hundred dollars a month. The supplement, which is paid to FERS employees who retire before becoming eligible for Social Security benefits, isn't issued until OPM finishes calculating a retiree's final pension.

My final advice is to keep all correspondence from the USPS and OPM in a safe place.

Federal retirees will receive a COLA hike in 2012, beginning in their January checks. Retirees in the CSRS will see a 3.6 percent increase in their annuities, while retirees in the FERS will see a 2.6 percent increase. Social Security precipitants will also receive a COLA increase of 3.6 percent.

Open season will be ending December 12, 2011, make changes and selections wisely, seek advice if needed.

Thanksgiving is a time of giving thanks, I hope everyone remembered to give thanks that they live in a country where we have a choice.

Christmas is a time to rejoice, rejoice in the fact we have the freedom of religion and speech.

Celebrate the Holidays with your family and loved one and remember our troops who protect our freedom.

Vouchers: Reviewed and approved all vouchers submitted to the State Board for payment. The new voucher, submitted at the September Board meeting, has been well received, it is easy to complete and easy to understand. The new voucher will be made available for use.

Minutes: Minutes of the September 9-10, 2011 were read. A motion made by Committeeman Pitts to accept the minutes, motion passed.

Equipment: The equipment assignment sheet has been reworked and will now be utilized. The equipment spreadsheet was distributed and checked for accuracy. All equipment will be listed and the spreadsheet will remain in the Associations' files.

Editor: Paper deadline November 15th. Editor Todd will have a contest to redesign the State Paper's front page heading. A new printer is still being sought. President Gamble and Editor Todd will schedule a meeting with a printer in close proximity to the editors' home location.

Board Policy: President Gamble made a motion to amend the corrective action board policy, motion passed.

Corrective Action Board Policy to read; Corrective action may be imposed on any OHRLCA member elected or appointed to a position within the Association for the following reasons, but not limited to;

A. Violation of the constitution or policies set forth by the OHRLCA State board.

- B. Neglect of duty or breach of the Constitution.
- C. Conduct detrimental to the welfare and interest of the membership or the Association
- D. Conduct, which hinders the due process of the grievance procedure.
- E. Instigating or engaging in acts on the side of management that violate the principles of the National Agreement or Constitution.

A discussion took place regarding the use of Article 4.3C as a means of taking corrective action against a subordinate unit officer for actions that would be considered misconduct.

Membership: A brainstorming session was con-

ducted on avenues to strengthen the membership. Possible solutions are, training on <u>OHRLCA.org</u>, question and answers in the state paper, also make available videos on the web site about mail count issues.

State Steward: The State Steward and Senior Assistant State Steward attended the Fall Steward Training held at Myrtle Beach, Oct 22-26, 2011. New Assistant State Steward Training was held at the National Office, November 7-11, 2011. Ohio sent 3 newly appointed Assistant State Stewards and the State Steward to the training.

State Steward Hutchisson reported there was not a great amount of route hour evaluation loss in hours because of the recent mail count. Northern Ohio and Cincinnati Districts had a net gain in hours. The USPS needed the routes to go down an average of 2 hours per route to break even and cover the cost of the mail count; overall the count went well for the Rural Carriers. The USPS predicted the districts would loose 5,000 hours per district this was not realized. State Steward Hutchisson and the Rural Route Analyst have agreed on over 60 mail count disagreement letters.

Past grievances that had been in abeyance, have now been worked and most of the issues have been resolved. Discipline is increasing within the state. Management is disciplining with the smallest of infractions. USPS is holding firm on removals.

National Steward System: National Director of Steward Operations Horne sent a request for nominations for the National Steward System in Ohio. The board completed the questionnaire with 6 names to be considered for the positions.

State Board Committeeman Position: The agenda moved to a discussion and deliberation regarding the appointment of a replacement for the vacant position of committeeman. Mark Funderburgh was selected.

Provident Guild: There were 29 delinquent premium payment letters sent to members. There are 5 new members since state convention.

GMAC: GMAC has a new rate code; carriers have contacted Committeeman Rowland with inquiries about the insurance. GMAC will give the Association \$10 for each quote requested by our members.

I wish to talk to the carriers about getting more involved in this organization. The union is about ALL of us, not a few to run the association. I realize life is busy for everyone and everyone has commitments. You only need to give four to five hours twice a year to attend your district meetings. Meetings last only two hours plus an hour for dinner.

We have all heard of Postal Officials wanting five day delivery. OMB (Office of Management and Budget) has said it is proposing to help the Postal Service reduce its' excessive operating costs by providing the flexibility to gradually move to five day delivery, beginning in 2013. Under this plan post offices still remain open on Saturdays, express mail is still delivered seven days a week, P.O. Box mail is still worked on Saturdays, and the USPS would still make Saturday deliveries in the busy weeks leading up to the winter holidays. The war is not over yet. This raises more questions than answers. One thing we can do is to stop paying bills on line.

Another thing each of us needs to do is to contact our Congress person in each of our districts. Would you believe there is a Congressman who wants you to take a yearly physical fitness test, at your own expense!?! This would include walking three miles while carrying a 35 pound satchel and lifting a 70 pound parcel off the ground then placing on a table every ½ mile. He also wants yearly random drug tests. On a lighter note, this Congressman wants ALL postmasters, managers, PCEs, and EAS personnel to carry mail for two weeks, twice a year. If this goes through could you imagine your supervisor or postmaster doing this? It could prove beneficial to all for them to realize just how much and how hard we work for them. We need to educate our Congress persons to what our job entails. Please contact them! If you don't know who your Congress person is go to OHRLCA.org.

I want to encourage everyone, whether you have a POV or a LLV to be prepared for the winter. Safety is your number one concern! For those of you with POVs check your tires for adequate tread and pressure, and make sure you have jumper cables, a blanket, a shovel and a bag of sand or salt. For those of you with an LLV (of which I am receiving around Thanksgiving) make sure you have an ice scraper and your Postmaster and supervisor's phone numbers. REMEMBER your LLV is a government vehicle. If you get stuck the postmaster or supervisor must be contacted to get you out. If a good Samaritan wants to pull you out BE CAREFUL! If anything happens to the LLV you will be responsible for damages and you could be setting yourself up for discipline.
