THE BEST DEFENSE IS A GOOD OFFENSE

I'm sure you have heard this phrase many times and of course the reverse as well, but in this day in age I believe the afore mentioned version is more applicable to this article. A recent surge in home invasions and burglaries caused us to start thinking about protections that we gave little consideration to before. Locked doors, an alarm system,

security lighting and even the thought of arming oneself in case of attack, were far from consideration before the danger became a real possibility. Now all of those steps have been taken and we are constantly on guard. This scenario led me to wonder what makes people want to take from others. I guess there is a lot of responses that could be made here, but I think the most prevalent reason is lack of options, or a perceived lack of options. Okay, so what's the point? The point is that it seems desperate people think that someone else and what they have is the cause or the only answer to a problem; and that the only solution is to take from them.

I recently had a conversation with a man who was reciting almost every negative thing he had heard in the media recently about the Union protections that were "causing our economic problems". He wanted to focus on how it was unfair for public sector (union workers) to pay less for health care than private sector employees. His solution; "make the public sector pay the same". In other words take the contract negotiated savings away from the public sector employees. Notice he didn't say; "create a solution that would allow the private sector to pay the same as the public sector. My answer was for him to imagine that the unionized workers had to pay the same as the private sector. Now, is there any guarantee that the supposed savings would translate into a different life for him? Absolutely not! Until you make it difficult or impossible for legislators or corporate CEO's to *spend* any new found savings...nothing will change.

We are faced with the same thinking when dealing with the Postal Service and the "cut, cut, cut" mentality. At a recent town hall meeting on the processing plant closures, the focus was entirely on what the Post Office had plans to cut. Cut jobs, close Post Offices, cut the delivery standards, cut retirement, cut pay and benefits to craft employees. Not one mention of new programs to generate revenue was ever

In fact, most of the cuts will hurt, even more, the first class customer we are losing. The plan to take away the "no layoff clauses" in our contracts and forcing people to retire has become a stated strategy. Multiple tier pay structures, that are beginning to become reality, are already causing animosity and hard feelings among the workforce. Ask someone who works at GM how it's working out.

Okay, I know you've been hearing this for sometime now and your saying to me "what can we do about it". Well now that we have the alarm system on and we're shining the security lights on the proposed cuts. Congress has heard us and has taken some stop gap measures. We need to arm ourselves against what we and others believe is bad policy. And here is my challenge for you. Try to think of revenue generating ideas or ways the Postal Service can save money with-

out cutting vital services. Ideas like offering discounts to first class mailers who mail often. (They do it for bulk rate customers). Or using Postal vehicles as advertising space. Okay, vou get the idea, now here is the twist...don't send it to the Postal Service, send it to your Congressional Represen-



What is Sequestration and how does it affect our craft?

Originally a legal term referring generally to the act of valuable property being taken into custody by an agent of the court and locked away for safekeeping, usually to prevent the property from being disposed of or abused before a dispute over its ownership can be resolved. But the term has been adapted by Congress in

more recent years to describe a new fiscal policy procedure originally provided for in the Gramm-Rudman-Hollings Deficit Reduction Act of 1985--an effort to reform Congressional voting procedures to make the size of the Federal government's budget deficit a matter of good choice rather than simply the arithmetical outcome of a decentralized appropriations process in which no one ever looked at the cumulative results until it was too late to change them. If the dozen or so appropriation bills passed separately by Congress provide for total government spending in excess of the limits Congress earlier laid down for itself in the annual Budget Resolution, and if Congress cannot agree on ways to cut back the total (or does not pass a new, higher Budget Resolution), then an "automatic" form of spending cutback takes place. This automatic spending cut is what is called "sequestration".

Under sequestration, an amount of money equal to the difference between the cap set in the Budget Resolution and the amount actually appropriated is "sequestered" by the Treasury and not handed over to the agencies to which it was originally appropriated by Congress. In theory every agency has the same percentage of its appropriation withheld in order to take back the excessive spending on an "across the board" basis. However, Congress has chosen to exempt certain very large programs from the sequestration process (for example, Social Security and certain parts of the Defense budget) and the number of exempted programs has tended to increase overtime - which means that sequestration would have to take back gigantic shares of the budgets of the remaining programs in order to achieve the total cutbacks required, virtually crippling the activities of the unexempted programs.

The prospect of sequestration has thus come to seem so catastrophic that Congress so far has been unwilling to actually let it happen. Instead, Congress has repeatedly chosen to raise the Budget Resolution spending caps upward toward the end of the legislative session in order to match the actual totals already appropriated, thus largely wiping out the incentives that the reformed budget procedures were expected to provide for Congress to get better control of the budget deficit. Unquote

Now that we see how Sequestration works, how

does it affect postal employees? The answer very simply is postal employee's health care and annuities could become unexempted programs. If Congress decides to exempt large programs (for example, Social Security and certain parts of the Defense budget and others) the cuts could be catastrophic to all unexempted programs.

You as retirees, regular carriers and relief carriers have fought the good fight over the last year to protect your health care, annuities and for 6 day delivery. You must keep up the fight! Congress will soon decide where to spend your money and the hours you work. Without your input they won't have to make a choice.

Continue to fill out your SAVE AMERICA'S POSTAL SERVICE petitions, call your Congressman and Senators and continue giving to PAC. Tell your representatives about your evaluated system and that your health care and retirement are fully funded and that it's not fair trying to balance the budget on the backs of hard working carriers. All of us together can make a difference. Please get involved.

Visit our State and the National websites for the latest news and calls to action; both at the local and national level. Talk to your fellow carriers, discuss your ideas and recruit the nonmembers to become the grass roots soldiers we need to take action necessary to protect what we have earned. The time to do nothing has passed. The threat is here and it's time to send in the OFFENSE! See you at the Booster! It promises to be one you will remember!!!

UNION DUES OR DENTAL INSURANCE

When times get hard the resolute employee pulls together with his fellow union members to find solutions that

will benefit all employees in the craft. For many years I have been traveling around the state and country on behalf of this Union and rural carriers. I frequently am asked by non-union members why they should join our Union. Today I received a letter from a member expressing her desire to withdraw from the Union.

The letter reads as follows: I mailed my request to withdraw from the Union today. There are two reasons for this

First is that after the last mail count, my evaluation dropped three hours per week. I had to choose between Union dues and dental insurance. I was already a H route after the count two years ago. Now I am a H route with a big pay cut to boot!

The second reason is that my reward for being the Local Steward for the past three years was that I have had a target on my back by the Postmaster. She has made an obvious attempt to intimidate me and I am tired of the fight.

First and foremost I would like to take this opportunity to thank you as a local steward for your hard work and dedication over the last three years. I know being a steward is at times difficult and time consuming and we have appreciated your efforts.

I too understand the effects of a devastating drop in mail volume. My route dropped nine hours in evaluation over the past three mail counts and the financial loss was substantial. Many carriers now have H-routes and are weathering big pay cuts.

My father was a member of the UAW and my grandfather was in the United Steel Workers Union. Both Unions have seen members suffer tremendous losses. Please do not blame a drop in mail volume on the Union. My father often said, "life is a marathon not a sprint". We can not solve long term problems quickly and we can't solve them by going it alone.

I have been on the front lines of Union membership building for the past ten years. I have personally traveled to over 200 Post Offices in Ohio and am always curious to hear the reasons for not joining the Union. Here are just a few questions that have been repeated several times to me over the years.

Why should I join the Union when I will get exactly the same wages and benefits without joining? I usually appeal to their sense of fairness and morality. That if there were no dues paying members then there would not be a Union to negotiate wages and benefits. Non-union employees tend to earn 20% to 30% less wages then their Union coun-

terparts. This is evidenced by the difference in pay of a TRC to an RCA.

I can't afford to join, I've got a family to support and my check just isn't big enough or the dues are too high. I typically get this response from RCAs who make up the bulk of our non-member carriers and I usually remind them that dues for an RCA is \$5.92 per pay period and if you don't work you don't pay that period. Furthermore a regular carrier only pays \$428.00 per year and this is one of the lowest dues structures among organized labor unions in America

My spouse would divorce me or my parents don't like unions. I explain to them that a large organization like the USPS is run like a paramilitary operation and that even managers and supervisors seek the protection of their respective unions. Protection and job security are key here, the cornerstone of family and union.

I don't need a union, my supervisor is fair and I get along with him. The facts are that 40% of all upper management is eligible for retirement and chances are that you will not have your current manager long. The USPS and the Union spends an estimated \$300 million dollars per year on grievance activity and labor issues due to the acts of poorly trained managers.

I can handle my own affairs and take care of myself or I don't intend to stay on this job forever as I am looking for a promotion. The reality of the situation is that most non-union employees do not get promoted before they get into trouble and are fired. They do not have access to union meetings, literature and mail count training classes. Many times the Union never knows they were fired.

My religion doesn't permit me to belong to any outside organizations. This is a fundamental difference of opinion and I have always respected it.

These are just a few questions and responses that I have encountered while out in offices membership building. Procrastination and ignorance of what the Union is and how to become a member are the main reasons for not being a member. In my ten years of experience I have never heard a carrier say they do not want to join because of an adverse mail count. Most carriers understand that mail volume dur-

ing a mail count is economy driven.

We consistently have from year to year about 320 RCAs that will not join the Union in Ohio. We have a retention rate of 70% of new hire RCAs in the USPS, 30% leave voluntarily or are fired. These are the most at risk carriers and they need the protection of the Union and they need the education the Union provides.

Current membership in Ohio is about 4225 with only 190 regular carriers being non-union members. But what would happen if more carriers were forced to choose between dental insurance and union membership?

Let me draw your attention to the most resent Arbitration award won by the Union resulting from an unfair labor practice charge filed by the Union on behalf of its members. The case arose after the Postal Service announced that it would be observing and recording rural carriers on their routes in a effort to reduce numerous time standards during the 2010 contract negotiations or subsequent interest arbitration. The Postal Service violated article 34 of the National agreement when it conducted time and work studies of over 400 rural routes without the Union's participation. The study involved the placing of video cameras in LLVs. Article 34's central goal is to establish fair work standards through mutual "transparent procedures." Without Union oversight and participation the Postal Service determines what is fair and equitable. Remember folks the Postal Service thought 69 pieces per minute was a fair standard for handling FSS flats.

Arbitrator Blocs' decision will ensure that the Postal Service engages in a participatory process for conducting time studies in the future. But more important it shows that together we can pool our resources, hire lawyers and consultants to advise us and fight for fair and equitable treatment for all.

I would like to address our writer's second reason for wanting to withdraw her union membership. I want every local steward in Ohio to know that you have the **full** support of my office and I **will not** tolerate any attempt at intimidation or harassment of a steward or any union member. It is the **Union's** position that every employee at every level of the Postal Service be treated at all times with dignity, respect, and fairness. A healthy work place is an environment where supervisors and employees have constructive dialogue with each other, where differences are recognized, and diversity is valued.

In closing I just want to say that the NRLCA helps carriers fight unwarranted discipline, discrimination and other abuses that can happen in an impersonal and sometimes hostile Bureaucracy. The Union has helped thousands of carriers win reinstatement, back pay, unpaid overtime and seniority rights. In addition to negotiating a fair and equitable wage and benefit package the NRLCA keeps an eye on safety and health conditions in Postal instillations across America.



CHANGE OF ADDRESS

OHRLCA uses the same address that you have on file with the USPS. Therefore, if you need to change your address, you have three options:

- 1. Use PS Form 1216, Employee's Current Mailing Address. Send it to: HRSSC, Benefits/Compensation, PO Box 970400, Greensboro, NC 27497-0400.
- 2. Call the HRSSC at 877-477-3273, option 5. Validate your identity with your Employee ID number or USPS Pin, then option 9 to speak to a service representative who will assist you.
- 3. For carriers with PC access: Log on to LiteBlue using your EID and USPS Pin. Click on the Change of Address/Phone/Emergency Contact link under Employee Resources. Your current information will be displayed. To update your information, click the edit button, and you're on your way. Follow the prompts to review, confirm and save your changes. That's it, you're done!

With this New Year comes a repeat of the two (2) percent reduction in the employees' portions of Social Security Tax. The reduction means you will continue to receive additional take home pay. Supposedly, the Social Security system's finances will not be harmed. The Social Security trust fund will be reimbursed for the full amount of the tax break from the general fund of the Treasury. The reimbursement from the general fund will add to the budget deficit.

MEMBERSHIP

As of January 12, 2012 the Membership Analysis prepared by the National Office has Ohio's total membership of 4302. The same report dated January 12, 2011 showed a total membership of 4537, a loss of 235 members in 12 months. A review of the rest of the states on the list indicates similar trends to those in Ohio. If your route is in need of a relief carrier, request that a RCA be hired as your relief. The Post Office is under no obligation to honor your request but we need to keep requesting RCAs.

July 8 - 10, 2012, Dayton Marriott, 1414 Patterson Blvd, Dayton OH. Plan to attend the State Convention, come and exercise your Union Rights. Listen to the concerns of fellow members, stand and speak, let your voice be heard on the issues. Attend the State Convention as a delegate and vote on the issues. How do you become a delegate to the State Convention? Be nominated during your District Meeting.

DISTRICT MEETINGS

At your District meeting District Officers are nominated and elected and delegates representing your district are nominated and elected to the Sate Convention. "According to our State Constitution both of these elections are to be by secret ballot." The elected delegates from your district will represent your interests on actions taken at the State Convention. If you wish to be a delegate to the State Convention from your District and cannot attend the meeting, be sure to let your District Secretary know so that your name can be considered when elections for District delegates are held. Names cannot be added to the delegate list after the district meeting has ended.

I hope that every member will plan to attend their District meeting that is listed in this issue. You are a member of the district that includes the county in which your employing office is located. Check which counties are in your District as listed on page 9 to determine which District you are a member of and eligible to be a delegate to the State Convention representing that District.

I hope everyone had a safe and enjoyable holiday season. I am glad I made it through with all the mail and parcels. WOW!! The USPS should have made money this year. I know we all delivered the parcels to the front door, not thrown on the porch or over a fence like our competitors. Great service is what we provide for our customers all year long—no matter what management says. The new year brings new responsibilities and new expectations. As the new year starts every rural carrier needs to check his or hers TSP contributions to be sure it is on track for your retirement date. You can never have enough, but you can get enough to live comfortably.

I want to encourage all members to learn the contract and know what we are required to do as well as what management wants us to do for free. If management wants you to perform work for free or against the contract—FILE A GRIEVANCE!! If management can get you to work for free they will continue to expect you to do work without compensation. Another thing that carriers do for free is to "work off the clock." NO ONE SHOULD BE DOING THIS!! If you work off the clock the hours performed are not recorded and hours worked in the rural craft and this understates the total hours our craft needs nationally to properly perform our jobs. Remember if it did not occur during mail count it's not in your evaluation. If you are not sure what is compensable ask your steward or call the state steward if there is no steward in your office. We need to properly record all work hours and stop giving management free labor. Unless management gives you permission to start early do not touch anything until your start time and then record all hours worked for the day on your PS form 4240. With contract negotiations going on right now we need all the correct hours for our routes. Management says we are working under our evaluation every day. Are we really working that many hours under the evaluation? This is why the postal service wants to lower the evaluations for mail being counted during mail counts.

I sent a letter to my Congressman, Jim Jordan, and he was nice enough to send a reply back, although he does need to be educated on a few things. He believes a number of sweeping reforms are needed in order for the USPS to continue providing the service the public has come to expect. He believes the problems range from too many facilities, excessive labor, and an ineffective pricing system. He supports HR2309 which includes the following provisions: steps would be taken to change the size of the USPS, it would include major reforms to personnel, delivery, pricing and facilities and, scariest of all, it would give the commission the option to go to five-day delivery, revise labor agreements, and require all mail customers to transition to curb side delivery within a two-year period.

Imagine if every member of Congress thought the same way—we would be in trouble. I encourage everyone to contribute to PAC in order to help educate members of Congress. Congressman Jordan believes we walk our routes to deliver the mail. If he truly believes this—I am underpaid, because I can not run 42 miles in 8 hours!

Some of the most important things that you as rural carriers need to have to navigate around in the postal world is your employee identification number and pin number. Also at some point and time you may need a copy of your form 50. First, you can find your identification number located on the top right side of your pay stub. Next, you will need your pin number. Forgot your pin number? You can find or change your pin by logging onto www.liteblue.usps.gov. This will give you an opportunity to reset your pin number if you have forgotten it. After logging on, look for the Employee Quick Apps Link, go to PostalEase Employee Web Main menu and follow the instructions to find your form 50. This is located in your OPF file. You will find that there is a lot more information on this site that you will find helpful. You can

make changes that pertain to your personal life for the New Year as well. Such as: tax deductions, catching up on TSP contributions or Payroll Deductions. You can also use the Employee Quick Apps Link to make a Change of Address or Bid on a route. You can be in touch with everything you will need to begin your New Year on the right foot. Make sure everything you have on file with the postal service is correct. If you find a mistake please contact Human Resources and our State Secretary to get the problem resolved. You may need to file that grievance or bid on that vacant route. So let's get ready and don't wait until the last minute. Everything is here right at your fingertips. As a reminder on March 24, 2012, the MOU states that vacant routes will be going up for bid. You, as RCAs and Regular Carriers will need this information. So let's be prepared.

One last thing that I would like to share with you is the importance of carriers not working off the clock. Right now we are in Arbitration with the United States Postal Service and one of the things that they are looking at is our time standards. Some carriers are getting done 4-5 hours or more under their evaluations each week. This doesn't look good for us. You need to go the Handbook PO 603: "Rural Carriers Duties & Responsibilities" and read for yourself what the rules and regulations have to say about working off the clock. So please write down your starting time when you touch that first piece of mail, cut that first strap, pickup that first tray of mail, or sort out your parcels. Those minutes add up. Make sure you are doing everything on the clock no matter what it is. You need to record your work hours accurately to assure evaluations are correct.

Who would profit if the Post Office went to a 5 day delivery, closing Post Offices and mail-processing centers? Who would profit if the Post Office were to be privatized, cut the first class standards from one to two days delivery to two to three days delivery? Who would profit from a cut to health care and retirement? Certainly not the loyal customers, businesses, or the postal workers. The Post Office is an important part of our economy and social fabric.

The USPS was created to provide a public service at the same level to residents, businesses and non-profits all over the United States with no area left unserved because of a profit nature. With closing Offices and process-

ing centers, the Post Office can not achieve a high standard. Why would we be willing to lower our standards in order to say we can reach our goals? It seems that this would create a decline in our business and erode public confidence.

I think most of have seen what happens when institutions are privatized or deregulated. Prices go up and the service declines and the workers and customers suffer at the hands of those in charge. The CEO and share holders are the ones who are looked after.

We are hearing more about breaking the unions and every state be a right to work state. Instead of bringing all workers standards up, it is a race to the bottom to bring middle class wages to a lower standard.

I attended the public hearing on Dec. 26, involving the closing of the Toledo mail-processing plant. The meeting started out with Todd Hawkins, postal service district manager for northern Ohio, outline the Post Office's reasons for the agency's decision to close facilities across the United States. The Post Office is using just the volume of first class mail to make their decisions in closings and cutting a day of service. I would not bank or pay bills on line with the amount of identity theft that I have been reading about. It is more secure to use the Postal Service. If I am correct in this thought, how can we afford to downsize?

Mayor Bell, many city council members, Toledo Public School Board Members. County Commissioners, City and County Court officials, Representative Kaptur, representatives from Senators Brown, and Portman, Representative Latta's offices, many Postal Union Representatives, and businesspeople were in attendance.

They all shared their concerns about the mail processing center closing and what it would mean to their businesses. They expressed how important it was to have next day delivery and by sending it to Detroit was of great concern.

Representative Kaptur, who was a letter carrier and understands the job, said, "This is a fight. This is a really big fight." The Ohio congressional delegation is seeking a review of criteria for the closing. They are aware of the problems with closing and the moving of the Lima Plant. They want to avoid more closings. They know the value of the jobs and the service the Post Office provides. Ms. Kaptur also expressed her support for the facility and urged us to take action, by writing members of Congress and vote for those who have the workers in mind.

There are 15 Senators who have requested a moratorium on the closing of the Postal Facilities to have more time to work with the Post Office to come up with a better way to make it more profitable with keeping Saturday deliveries. This moratorium presents us with the most opportune time to tell our Representatives our side of the story. A huge item on Senator Brown's agenda is to deal with the fact that the USPS cost of paying more than \$5 billion every year in future retiree health care benefits. He is very concerned about the service to the people and the jobs that will be lost with downsizing.

We can not let our guard down. Keep writing. Our jobs are at stake.

WARNINGS IGNORED

The winter of 2011-12 proved deadly for a snowmobiler near Bozeman, Montana when he ignored a warning about the danger of an avalanche. Rural carriers are given warnings about a number of dangers: vehicle accidents, slips and falls, back injuries, etc. Sometimes a person is cautioned to watch out for an individual who is a troublemaker [Alexander the metalworker] about whom the Apostle Paul warned Timothy in the Bible.

Other kinds of warnings are also important. Smoking is dangerous to one's health, along with the abuse of alcohol and drugs. Some rural carriers have ignored warnings about flirting with another's spouse and have been caught up in adultery and broken marriages.

On the highway we sometimes see signs that urge caution about conditions ahead. It is just as important to heed warnings in the realm of health, safety, and appropriate moral conduct.

MAILING LISTS

Department of Labor regulations related to using the Association mailing list to promote a candidacy for an elected state office or position.

A union must honor all reasonable requests by a candidate to distribute campaign literature at his expense to all members in good standing, whether the distribution is by mail or some other means. The union may not censor the contents of campaign literature it is requested to distribute.

It must treat all candidates fairly. If its distribution of campaign literature for one candidate is without charge, then its distribution for all candidates must be without charge. Treating all candidates the same by refusing to honor any and all reasonable requests for distribution of campaign literature at the candidates' expense is not permitted, however. To avoid charges of unequal treatment among candidates, the union should inform all candidates in advance of the conditions under which it will distribute literature and should promptly advise them of any change in those conditions.' To comply with the last sentence of the above paragraph the board has established that any candidate wanting a mailing to be made should prepare the mailing for entry into the mail stream. Once it is prepared it should be forwarded to the State Secretary-Treasurer's office where labels will be prepared and affixed for either the entire state membership or a specific requested area, based on county lines, desired to be covered and the labels will be affixed. The cost will be the cost of the labels and the cost to affix them to the mailing. If you have questions, please contact me.
