What about Labor Day? What's it stand for?

1872 Toronto, Canada: Labor Day began in Toronto as a significant demonstration with a purpose of demanding rights for workers.

1882 – New York, New York: The first U.S. Labor Day was celebrated on Tuesday, September 5, 1882 in New York

City and was organized by the Central Labor Union. The Labor Day parade consisted of about 10,000 workers who took unpaid leave. These courageous individuals marched from City Hall, past Union Square, uptown to 42^{nd} street and ended their journey at 92^{nd} St. and 9^{th} Avenue for a concert, speeches and a picnic held in Wendel Elm Park.

1887 - Oregon: Oregon was the first state to make Labor Day a holiday in 1887.

1894 – Congressional Action: On June 28, 1894, Congress passed an act making the first Monday in September of each year a legal holiday in the District of Columbia and the U.S. Territories.

What is the purpose of Labor Day? Labor Day celebrates and promotes the contributions and achievements of the men and women of the U.S. workforce; over 155 million individuals of all races, creeds, and faiths.

Did you know that in the late 1800s, the average American worked 12 hours a day and seven days a weeks, to eke out a basic living? Also, children as young as 5-6 years old worked in factories and mines.

With the passage of the Adamson Act in 1916, the 8-hour work day was firmly established. This was the first federal law regulating hours of workers in private companies.

Through the courage and diligence of our predecessors, unionized postal workers today have good paying jobs, benefits and retirement plans. None of these perks came easy and the battle rages forth.

Much as our predecessors had challengers to their labor rights, we also have ours. Certain members of both Postal Management and of Congress want to destroy the laborer's legacy. Will you stand up and fight for your job, your benefits and for the greatest organization in the world (your United States Postal Service), or will you let mentalities similar to that of Patrick Donahoe and Darrell Issa chip it away until there is nothing left?

You want to do something but don't know where to start? It's easier than what some may think.

Contact your representatives and request that they oppose all closures and cuts, save both six day delivery and at- the- door delivery. Demand a repeal of the pre-funding mandate and support H.R 630, H.R. 711 and S. 316 to fix the finances.

Network Rationalization Continues

The United States Postal Service issued a letter to its customers advising of its plans to resume Network Rationalization (closures and consolidations) of its network of mail processing facilities that began with Phase I in July 2012.

During Phase I, approximately 46 plant consolidations occurred. The District Representative USPS then paused for the 2012 fall mailing season, election mail and holiday mailings. In January 2013, they

resumed with 95 more consolidations that continue through October. Phase II was originally scheduled to begin February 1, 2014 with the adoption of First Class service standards that would eliminate the intra-plant overnight commitment for collection mail (a mailer presort delivery option would be preserved). Phase II, consolidation depends upon the elimination of the overnight delivery standard and it was unclear whether proposed legislation would permit this and to date no legislation has been passed.

The overall plan sought to close 250 mail processing & distribution centers of which ten are in Ohio, including Akron, Athens, Canton, Chillicothe, Dayton, Mansfield, Steubenville, Toledo and Youngstown. The announcement created uproar among local business leaders and lawmakers, prompting Sen. Sherrod Brown (D-OH) to demand the USPS release the Area Mail Processing (AMP) study it used to make its decision. So far, the USPS has been unwilling to release the reports and Ohio lawmakers were not alone when it comes to stone walling by the USPS on this issue.

Sen. Susan Collins (R-ME), Steve King (R-IA), Carl Levin (D -MI) and Congresswomen Grace Napolitano (D-CA) among others have requested AMP studies for their States and have only received redacted (blacked out) versions that are inconclusive. Iowa lawmakers filed a Freedom of Information Act request to get the information and the USPS said it would provide the report, but it would cost \$831,143.16. Yep, you read that right, over \$800K to get a copy of the report.

When the USPS announced the Network Rationalization plan to consolidate 250 area mail processing plants and eliminate 34,000 jobs back in September 2012, they said it would save \$3 billion a year. When the USPS presented its case to the Postal Regulatory Commission in December 2012, they said it would save \$2.1 billion. But the numbers on cost savings and affected positions that postal managers presented at public meetings for each facility don't add up to anything like that. The estimates provided at those meetings appear to have downplayed how many jobs would be lost, and they also raised questions. Can the Network Rationalization plan really save as much as the USPS says?

How the USPS arrived at its cost saving estimate is very difficult for non-experts to understand since it involves very complex calculations and a thorough knowledge of the nuances of the mail stream. But the basic principal is not hard to grasp. Eliminating 34,000 positions would save about \$2 billion a year (figured at \$60,000 per position for salary and benefits). Another half billion would be saved in non-labor costs, but there would also be a half billion dollar lose in revenue due to the reduction in service standards. That leaves us with about \$2.1 billion in total savings.

The Network Rationalization plan is filled with page after page of details about how the cost savings would be achieved, but there is no plant-by-plant breakdown. Ohio lawmakers would like that breakdown because when you look at the numbers for cost savings on each plant, they just don't add up to the USPS estimate of total cost savings. Some watch dog groups have identified major discrepancies that total over a half billion dollars per year, nearly half of what the USPS says it will save.

In each of the Ohio communities where public hearings were held, the USPS gave a power point presentation that included some financial estimate, but they were very sketchy. In some cases, the presentation simply provided the total amount that would be saved and the number of positions that would be eliminated, with no other details. In other cases, the presentation broke down the cost savings into four main categories including work hours, management, maintenance and transportation costs.

The National Postal Mail Handlers Union (NPMHU) on March 3, 2012 published the AMP studies for 134 of the 250 proposed closures under the Network Rationalization plan. Though heavily redacted, these reports contained a lot of numbers on cost savings and eliminated positions, along with a narrative explaining the savings and staffing changes.

If you add up the numbers for these 134 facilities and then estimate what the total cost savings for all 223 facilities slated for consolidation would be, you end up with a total savings of \$874 million. If you subtract the \$500 million in lost revenue the USPS anticipates the reduced service standard will cause, your left with \$374 million in savings for the entire Network Rationalization plan. That's less than 20% of what the USPS says the plan will save.

It looks like the NPMHU is a lot closer in their prediction of any projected savings. What we know following Phase I is that the USPS reported a savings of \$865 million with 60% of the total Plan closures completed. The Postal Service "expects the completion of Phase II of network rationalization to generate an additional \$750 million in annual savings". I want to remind you that the original projection was \$3 billion then revised down to \$2.1 billion and now it looks like \$1.6 billion if you can believe the latest numbers. This has prompted 160 members of the US House Of Representatives to oppose Phase II and seek to stop the proposed closings of 82 additional mail processing facilities.

Rep. Ed Joyce (R-OH) and Rep. Ron Kind (D-WI) spearheaded a letter sent to House appropriations Committee Chairman Hal Rogers (R-KY). The letter called on House Appropriations leaders to include in the stopgap funding bill a one-year moratorium on the closure of the 82 mail processing facilities, beginning January 2015. The letter said in part, "The Postal Service has already consolidated 141 mail processing facilities since 2012. As the postal network has been weakened, service has suffered. Since the Postal Service slowed down the processing and delivery of first class mail over two years ago by revising its service standards, it has been more difficult for the American public and small businesses to receive mail in a timely manner. Slowing down mail delivery even further will especially hurt senior citizens on fixed incomes, small businesses, rural areas, and the economy.....This one-year moratorium will give Congress the time it needs to enact the comprehensive postal reforms that are necessary for the Postal Service to function effectively in the future."

The reality of the plans Phase II will see 82 communities (in 37 States) suffering a big economic hurt when the plants close with thousands of workers displaced and approximately 10,000 positions eliminated. First-class mail standards will have to be lowered, inflicting immeasurable harm on the postal service brand and reputation.

The new guarantee period will begin on Saturday, October 18, 2014 and now will be the time to sign up for the Relief Day Work List (RDWL) and is referenced in Article 8.5 of the National Agreement.

Ohio Valley DR Cathy Funderburgh Can management make the relief carriers split a route to avoid using the RDWL? Yes, management can require relief carriers to split a route before using anyone on the RDWL.

Is management allowed to make the relief carriers carry more than one route? Yes, management can schedule a relief carrier to carry two routes in a single day but the daily evaluations of both routes can not be over 12 hours.

Can management bring in another relief carrier from another office before using the RDWL? No, management can not bring in a relief carrier from another office in order to avoid using the RDWL.

If I am on the RDWL and I have plans for that day then can I refuse to work? No, you can not refuse to work. By signing the RDWL, you have agreed to work your relief day as needed.

Can I be made to work if I am on leave the day before or the day after my relief day? No, that is the one time the union will argue that you can refuse to work. However, you can tell management that you do not wish to be by passed and are willing to work your relief day.

If I have plans then can I just get off of the list so I won't have to work that day? No, once you have been told that you will be needed to work then you must work that day. However, you can get off the list at any time after that point.

If I get off the list, then will I be able to sign up for the **RDWL?** You will have to wait until the next signing period.

When is the sign up period? You can sign up to work your relief day twice a year. First opportunity is the three weeks prior to the beginning of the new guarantee period and the second time is three weeks prior to the beginning of the first full pay period in May.

How long is the list posted for? Two weeks.

Does the new list supersede the previous list? Yes.

I am the next in rotation to work but management said that they have to start at the top because of the new list. Is that correct? Yes, the new list supersedes any previous list.

Is the list on a rotating basis or is the senior carrier allowed to work all the time? Yes, the list is on a rotating basis starting with the most senior carrier.

Is it possible for the same carrier on the RDWL to be selected each time? Yes, if that carrier is the only one to have the relief day that is needed.

If there is a need to work a regular carrier due to an unscheduled absence, is management required to call a carrier on the RDWL? Yes, the next carrier in rotation who is not on leave and not working that day.

What happens when there is still no one to work? Management will ask for volunteers to work. If no one volunteers then the regular carriers will be ordered to work by junior regular.

Is assigning the junior regulars on a rotation bases? No, the junior regular can be forced in each and every time unless the carrier is in 2080 problems or will exceed 56 hours in one week.

If I work, then where will my relief carrier work? The relief carrier can be assigned to any route in the delivery unit with the provisions of the National Agreement. If the leave replacement has never served the open route, but is qualified on other routes in the delivery unit, then management may change assignments with another leave replacement, who has experience on the route needing coverage. However, RCAs serving their primary route assignments or an auxiliary route may not have their assignments changed.

If management violates the RDWL and I file a grievance over it then can I be paid for it? No, administrative errors in the assignment of work to regular carriers on relief days will not result in monetary remedies.

What is an "administrative error"? It is an honest mistake or error. Are there any ways to correct an administrative error? Yes, by allowing the carrier to make-up the missed opportunity to work.

I am on the RDWL but I am exceeding 2080 hours and management skipped me. Are they allowed to do that? Yes, the employer is not required to work any carrier if it would cause the carrier to exceed the guarantee hours or 56 actual hours within one week.

How do I get paid for working my relief day? The carrier will have a choice. A DACA Code 3 will allow the carrier to receive an X day plus 50% of their daily rate of pay. A DACA Code 5 pays the carrier 150% of their daily rate.

Where do I write a DACA Code at to ensure that I am paid correctly? On your PS Form 4240, place the DACA Code number in column 8 (Sub hours) on the corresponding day.

What is an X day? An X day is when the carrier will be paid to take the day off- much like a day of annual leave.

If I am NOT on the RDWL then can I be paid a DACA Code 5? No, you can only receive a DACA Code R or a DACA Code 3.

If I take a DACA Code 5 then will I receive an X day? No, only carriers using a DACA Code 3 will receive another day off.

How long do I have to use an X day? 12 weeks.

Who will determine when I get to use the X day? Management will schedule the day off.

What will happen if my X day is not used within 12 weeks? The carrier will be paid 100% of their daily rate of pay in lieu of the X day that was earned.

Is there any time of the year that an X day earned must be taken in the same pay period? Yes, any X day earned from the start of the guarantee period through the end of the Christmas period must use the X day in the same pay period or the carrier will be paid 100% of their daily rate of pay.

What is a DACA Code R? The regular carrier agrees to work their relief day without any over time so that the relief carrier may have a day off.

I worked my day off but did not receive additional pay. What should I do? Carriers always have the right to file a grievance. However, the best way to avoid this issue is to have the additional pay issue worked out BEFORE you work your relief day.

I hope this answers all of your questions on the Relief Day Work List. When in doubt, call your union steward. Be safe and stand up for yourself!

As of September 13, 2014, the Membership Analysis prepared by the National Office has Ohio's total membership at 4246. The membership consists of 2150 Regular Carriers, 894 Retired Carriers, 1194 Relief Carriers and 8 Associate Members. The Membership Analysis dated September 13, 2013 had Ohio's total membership as 4149. Ohio has 97 more members than the same date last year. We need to continue our efforts to recruit new members. The strength of our union is our members; to remain strong we need to increase our membership. Do your part and invite a recently appointed RCA to join the NRLCA.

During the 2013 National Convention the delegates passed an amendment to the NRLCA Constitution, Article III Section 6 Dues. Membership dues are figured by a percentage of your salary. The percentage computation will automatically adjust dues with each salary adjustment. You received a recent salary adjustment for COLA, which increased your salary and will also increase your dues. A salary chart will be available at nrlca.org.

Ohio had 43 Delegates at the National Convention in Grapevine Texas. Thanks to all who represented Ohio at the National Convention. A list of the attendees is published in this issue. These National Delegates made decisions that will directly affect your work life, paycheck and the OHRLCA sssets. Ohio's delegates were sent to the National Convention to represent you. Please take time to speak to a delegate and ask; how they voted on the issues brought forth on the Convention Floor?

The NRLCA offered many seminars during the National Convention.

When you retire you must meet one of these requirements;

Age 62 with 5 years of creditable service

Age 60 with 20 years of creditable service

Age 55 with 30 years of creditable service

Creditable service includes, career time, non-career service time and military service for which deposit was withheld. Noncareer deposit is explained in the September 2013 issue of the National Rural letter Carrier Magazine pages 374 - 376.

Open season for FEHB begins Monday November 10, 2014 and ends December 8, 2014. During the "Open Season" you may enroll and make changes in the Federal Employees Benefit Plans. Please remember to take full advantage of the U.S. Postal Service's Flexible Spending Account (FSA) program for regular and PTF rural carriers. The FSA program allows carriers to pay for child or adult daycare expenses and family health care expenses, which are not reimbursed by insurance, with tax-free dollars.

Enjoy the beautiful fall weather and I hope you plan to attend your Fall District Meeting.

On Veteran's Day, November 11th, remember our Veterans who served to keep the United States of American free. On Thanksgiving give thanks for your freedom.




Labor Day is celebrated on the first

Committeemen Tim Barker and myself, Mark Funderburgh, are your new PAC co-chairs for 2014-2015. We are going to be asking for your continued support at every upcoming meeting.

We have a few changes for this year. The first is a meat raffle for \$25 per ticket or \$100 for 5 tickets. You will be eligible to win one of three 250-pound packages of grass fed shorthorn beef. The meat will be processed and delivered to your door ready to be put into your freezer the first week of December. Prizes to be drawn at the fall booster on November 9, 2014. Legislative

At National Convention I attended any legal or legislative seminar that I could to learn what was going on in Washington. The outlook is not good. It all depends on how the upcoming elections will go to see if anything will get done before the end of the year concerning the postal service and the financial obligations for the mandated payments. While at the legislative seminar I asked about printing the results of how our Congressmen and Representatives voted concerning postal issues. I was told it was not illegal to print this information in our newspapers. We are not trying to sway anyone's vote one-way or the other---we are just giving you information.

The Postal Accountability and Enhancement Act of 2006 (PAEA) mandated that the postal service make annual payments ranging from 5.4 to 5.8 billion dollars from 2007 to 2016, in order

to finance retiree health benefits beginning in 2017. Also mandated by PAEA is a separate payment to the office of personnel management to pay for current retiree health benefits. The trust fund has roughly 46 billion dollars, more than enough to meet current and future needs beyond 2025. This requirement has resulted in almost 80% of the USPS losses over the last 6 years.

There are a number of bills in Washington being currently discussed, some very detrimental to the postal service while others are helpful to "righting the ship." S 1486 allows the USPS to go to 5 or fewer days of delivery resulting in the elimination of more than 50,000 rural letter carrier jobs. S 1486 would enact drastic service standard changes to first class mail and eliminate overnight delivery. S 1486 extends the pre-funding mandate and the financial burden it creates. S 1486 would make FERS and TSP contributions subject to collective bargaining. We would have to negotiate for benefits other federal employees receive automatically. S 1486 gives the USPS the authority to create a postal only health plan.

HR 2748 eliminates 6-day delivery immediately. HR 2748 interferes with the collective bargaining establishing a mandatory arbitration process leaving the employer and employees much worse off. HR 2748 allows postal facilities to close without regard to the employees or community around them, thus providing slower and lower quality services. HR 2748 extends the financial burden congress enacted in 2006.

These two bills do nothing to correct the financial problems of the USPS. The postal service is an American institution with substantial importance to American households and businesses. The postal service should make it a top priority to continue universal service. The bills that help the USPS are S 316 and HR 630 they protect 6-day mail delivery and eliminate the mandate to pre-fund retiree health benefits. They allow the postal service to provide non-postal services or products consistent with the public interest. They prohibit the USPS from increasing the expected delivery time of market dominant products. They also put into place criteria for consolidation or closing of postal facilities. On September 4, 2014 U.S. Senate majority leader Harry Read (Democrat-NV) signed onto a bill that calls for a one-year moratorium on the closure of up to 82 mail processing plants and the elimination of up to 15,000 jobs. The USPS continually attacks us and tries to take away our livelihood. The rural carriers of America need everyone to stand up and fight for the protection of a once great, sound, and stable American institution. Contact your Congressman or Representative and let them know that you care about the postal service and your customers.

First, lets talk about the legislative side of things. Congress has adjourned to campaign for the upcoming elections. They plan to return for a short legislative period after the elections known as a "lame duck" session. The Republicans currently hold the house, and they are expected to maintain control after the elections. The Senate, currently controlled by the Democrats, is very much in play this election cycle, and there is a strong possibility control of the Senate could flip to Republican control. The outcome of the elections will determine how much gets done during the lame duck period. If Republicans take control of both the House and the Senate, I do not expect to see a lot get accomplished during the lame duck as the Republicans will enter the new 114th Congress in January to push their own agenda. If congress remains divided as it currently is, we may see a little more legislation get passed, but probably not very much. The Democrats must run the table to win back the House, and they must win every solid Democratic district, likely democratic district, lean democrat district, toss-up, and 15 out of 16 lean Republican districts to take back the House. This is probably not going to happen, so how does this affect us, the rural carrier's? Well there seems to be more Democrats supporting the USPS right now so with more Republicans coming in we must educate the new incoming elected officials about our rural carrier craft, six day delivery, and how we provide a service to our rural communities. Remember folks who we are dealing with. For example a person born and raised in the city of Chicago becomes an elected official and moves to Washington D.C. to be a life long politician. They may have never seen a cow in a lush green pasture in Ohio. You ask them where their milk comes from and they might respond, "from the supermarket". They don't think about the registered voters running a dairy farm in Ohio. It's the same with our rural craft. They don't know about us, every address in America serviced six days a week including that registered voter running a small dairy farm on a dirt road in rural Ohio. That is why the next year is so important for us to support PAC. With the money we donate to PAC we will be able to get some one on one and/or small group meeting time with these politicians who vote on the bills that affect us directly as rural carriers. We can educate them on our jobs and the services we provide to our rural communities that help keep America connected and informed.

We sell customer service to our customers on our rural routes with a warm smile on a cold winter day, making sure to take that certified letter to the door, and being sure to place that parcel in a safe, dry place. vives.


Bob is also survived by his sister, Helen Snyder of Oak Harbor and sister-in-law, Phyllis Reese of Pandora


